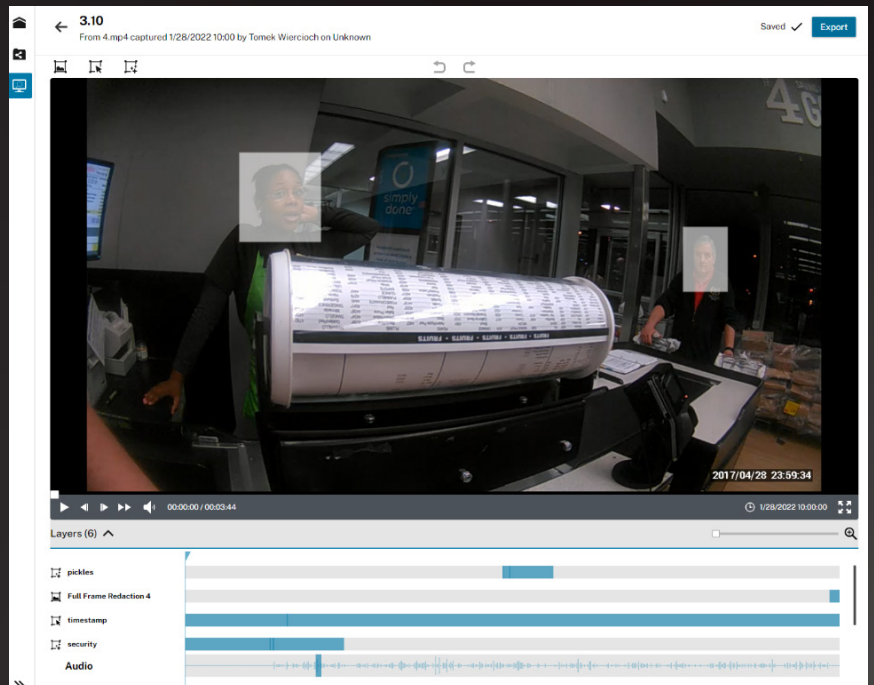

FLEXIBLE REDACTION OPTIONS TO MEET YOUR NEEDS

Redact or inverse redact an object or area, and redact audio with a robust suite of native, cloud-based tools. When it comes to group recordings, you may also have multiple sources of audio and video. Simply select your desired video and audio source and start redacting that combination right away with these four redaction tools:

- **SMART TRACKING:** Automatically track and redact an object — or its background — as it moves around the screen, saving time.
- **MANUAL REDACTION:** Manually track selected objects with frame-by-frame control or redact a section of the screen through the entire video.
- **FULL FRAME REDACTION:** Quickly and easily redact the entire screen to obscure large crowds of people, sensitive locations, or in-vehicle time segments.
- **AUDIO REDACTION:** Mute or censor beep a portion of a video's audio by highlighting the desired time range. The sound wave bar makes it easy to choose the exact frame where the audio redaction should begin and end. You can also redact multiple time segments in the audio layer.

However, redaction is only as good as one missed frame. Our Smart Tracking tool helps users detect when a frame may have been missed and automatically pauses the video so the error can be corrected. But there is no substitute for the human mind: Motorola Solutions recommends you review your project in its entirety to ensure every frame has been properly redacted.

TRIM LONGER VIDEOS

Create shorter clips of longer videos to narrow in on the exact segment for the redaction project. This also expedites redaction by processing a shorter video.



PROJECT REVIEW TOOLS

Tab through the video frame-by-frame or slow the speed of the video for more granular review to make sure every frame has been properly redacted.



PREVIEW EXPORTS

Preview the visual effect options to make sure you are happy with the final result before downloading or sharing the exported redacted project.



COLLABORATE ON PROJECTS
